THIS MATTER CAME BEFORE THE COURT ON AN APPLICATION FOR THE SEALING OF THE RECORDS FILED PURSUANT TO R.C. 2953.32. UPON DUE CONSIDERATION, THE COURT FINDS THAT: (1) THE APPLICANT IS A "FIRST OFFENDER", AS DEFINED BY R.C. 2953.31(A); (2) THE PENDING APPLICATION WAS FILED IN A TIMELY MANNER; (3) THERE IS NO CRIMINAL PROCEEDING AGAINST THE APPLICANT; (4) THE APPLICANT HAS BEEN REHABILITATED TO THE SATISFACTION OF THE COURT; AND (5) THE INTERESTS OF THE APPLICANT ARE NOT OUTWEIGHED BY ANY LEGITIMATE GOVERNMENTAL NEED TO MAINTAIN SUCH RECORDS.

IT IS ORDERED THAT ALL OFFICIAL RECORDS PERTAINING TO THE CASE BE SEALED AND, EXCEPT AS PROVIDED IN R.C. 2953.32(F), ALL INDEX REFERENCES TO THE CASE BE DELETED.

IT IS FURTHER ORDERED THAT NO OFFICER OR EMPLOYEE OF THE STATE, OR ANY POLITICAL SUBDIVISION THEREOF, SHALL KNOWINGLY RELEASE, DISSEMINATE OR MAKE AVAILABLE FOR ANY PURPOSE INVOLVING EMPLOYMENT, BONDING OR LICENSING IN CONNECTION WITH ANY BUSINESS, TRADE OR PROFESSION TO ANY PERSON, OR TO ANY DEPARTMENT, AGENCY OR OTHER INSTRUMENTALITY OF THE STATE OR ANY POLITICAL SUBDIVISION THEREOF, ANY INFORMATION OR OTHER DATA CONCERNING ANY ARREST, COMPLAINT, TRIAL, HEARING, ADJUDICATION, CONVICTION OR CORRECTIONAL SUPERVISION, THE RECORDS WHICH HAVE BEEN SEALED PURSUANT TO THIS ORDER, EXCEPT AS AUTHORIZED BY R.C. 2953.32 (D), (E), AND (F).
